Dear ENERGY STAR® Computers Partner or Other Interested Stakeholder,

With this letter, the U.S. Environmental Protection Agency (EPA) is releasing the Final Draft, Version 7.0 ENERGY STAR Computer specification. EPA thanks stakeholders for the feedback that they provided and has taken that feedback into consideration in developing this draft specification.

This final draft reflects significant engagement with stakeholders and strikes a reasonable balance across the numerous criteria that make up this specification. The modest adjustments to the base allowances proposed in the November 14, 2017 memo as well as the memory adder were retained. However, in response to stakeholder feedback, EPA adjusted the p-score boundary between notebook category 1 and 2 to allow those products with a p-score of 8 to meet the category 2 requirements. Significant comments were also received on the incorporation of mobile workstations into the specification. As such, EPA will collect data on these products with the intent of proposing energy efficiency criteria as part of a Version 7.1 to follow closely on the finalization of Version 7.0. In the interim, mobile workstations will continue to be eligible for certification under the notebook criteria. EPA also received comments regarding the full network connectivity definition and the requirements to obtain the full network connectivity mode weighting. These criteria were amended to more clearly indicate what manufacturers must do to use this mode weighting. Modest adjustments were also made to the workstation and full network connectivity definitions, the internal power supply requirements, and the international market certification section of the specification.
